

Dear Mr. Widerburg:

In its Report and Order dated May 28, 2021 in Docket No. 21-057-10 (Order), the Commission authorized Dominion Energy to extend Tax Surcredit 3 by 12 months, beginning on June 1, 2021 and ending May 31, 2022, in order to collect an approximate \$1 million EDIT balance. The Order also states that any remaining EDIT balance must be reported and included in the Company's fall 2022 infrastructure tracker rate adjustment filing. In compliance with the Order, the Company will cease billing Tax Surcredit 3 effective June 1, 2022. The Company has attached the relevant sections of Dominion Energy's Utah Natural Gas Tariff (Tariff) as DEU Exhibit 1.1 that reflect the elimination of Tax Surcredit 3. When all billing cycles that include Tax Surcredit 3 are complete, the Company will measure the remaining EDIT balance and include that balance as an adjustment to the infrastructure tracker rate adjustment filing in the fall of 2022. The following table details the sections of the Tariff that have changed:
