On 5/31/21 I contacted Dominion Energy about a gas smell in our building and after 2 visits that same day it was determined there was a gas leak in one of the units main lines that run through the common wall near my unit. I have attempted 3 times to request the report of findings and also repair from Dominion's legal department and they are not returning my inquiries with the requested information (they are withholding the report). I need this information to determine liability for the medical damages I sustained from the gas exposure in my unit and Dominion is not providing. Can you please assist me with this process? Thank you.

SUGGESTED RESOLUTION: Dominion Energy should provide me a full report of findings from the gas leak on 5/31/21 at 8450 Gambel Drive, Park City, UT and also provide liabiilty information for damages.

My original call to Dominion was placed when Reagan Cottrell and I both smelled gas in our common area building hallway on 5/31/21, primarily in the area outside my front door. When the Dominion technician came out the first time he did not initially find the main gas line leak, so Ms. Cottrell called Dominion back a second time, less than one hour later. Both service calls placed on 5/31/21were related to the same exact issue with the gas leak and should be treated as such. Ms. Cottrell's service report from Dominion should not be confidential as it contains information pertinent to all tenants of 8540 Gambel Drive, as the gas leak was found in our common wall. 
