On January 11, 2012, Cathlin A. Peel ("Ms. Peel") filed a formal complaint with the Division of Public Utilities ("Division") against Questar Gas Company ("Questar"). See Formal Complaint, filed January 11, 2012. Ms. Peel claims she is being wrongly charged over \$2,600 for services she did not receive. See id. Ms. Peel further claims the charges for which she is being held accountable are for bills incurred by other customers than herself. See id.

On January 11, 2012, the Commission sent an action request to the Division to analyze Ms. Peel's complaint. <u>See</u> Action Request, filed January 11, 2012. On February 1, 2012, the Division filed a recommendation that no further action be taken due to Ms. Peel's bankruptcy petition (Pet. No. 12-20353) filed on January 11, 2012. <u>See</u> Division Recommendation, filed February 1, 2012.

On February 8, 2012, Questar filed a request for extension of time to file its response, given Ms. Peel's pending bankruptcy. <u>See</u> Questar's Request for Extension of Time, filed February 8, 2012. Questar served its motion on Ms. Peel on February 8, 2012. <u>See id.</u> Certificate of Mailing. Ms. Peel filed no response to Questar's motion, and the 15-days in which to do so has elapsed. See Utah Admin. Code R746-100-9(D).

On February 23, 2012, a status conference was held before the administrative law

on behalf of Questar, and Patricia Schmid appeared on behalf of the Division. Ms. Peel did not

attend. Both Questar and the Division agreed that this case should be stayed pending resolution

of the pending bankruptcy.

Given that the Office's motion is unopposed and for other good cause appearing,

the Commission hereby enters a stay of the proceeding pending resolution of the bankruptcy

petition (Pet. No. 12-20353). If, at a future date, a party believes good cause exists for lifting the

stay, that party should file a motion seeking vacation of the stay.
