After hearing from the parties and being fully advised, the Commission makes the following order regarding schedule and procedure in this docket:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that:

1. All parties may conduct discovery until April 15, 1999.
2. All dispositive motions must be filed and served on or before May 10, 1999.
3. Petitioners shall file and serve pre-filed direct testimony on or before May 10, 1999.
4. A hearing on any dispositive motions filed will be held on June 8, 1999 at 9:00 a.m.
5. Respondent Questar shall file and serve its pre-filed testimony and work papers on or before June 30, 1999.
6. Rebuttal pre-filed testimony by any party shall be filed and served on or before July 30, 1999.
7. Any sur-rebuttal pre-filed testimony by any party shall be filed on or before August 16, 1999.

8. The hearing on this matter shall commence on Tuesday, August 31, 1999 at 9:00 a.m. and conclude on Wednesday, September 1, 1999. Thursday, September 2, 1999 shall be held open by the Commission and all parties to complete the hearing, if it cannot be completed in the two days allotted.

9. All discovery conducted prior to April 15, 1999 shall be responded to within thirty (30) days of service of discovery requests. For discovery by any party of matters relating to pre-filed testimony after April 15, 1999 such discovery shall be responded to within twenty (20) days of service and the responding party shall attempt in good faith to respond in 14 days.

10. All hearings set forth in the foregoing schedule shall be held in the Commission's main hearing room #426, fourth floor, Heber M. Wells Building, 160 East Third South, Salt Lake City, Utah unless otherwise noted.
