Dear Ms. Orchard:

MidAmerican Energy Holdings Company ("MEHC") and PacifiCorp submit to the Utah Public Service Commission ("Commission") an original and five (5) copies of PacifiCorp's Annual Report of Status of Commitments ("Status Report"). This Status Report is being provided in compliance with General Commitment 49 and State-specific Commitment U28, pursuant to the Commission Order granting approval of the acquisition of PacifiCorp by MidAmerican Energy Holdings Company, issued March 14, 2006, in the referenced proceeding.

The Commission approved the acquisition of PacifiCorp by MEHC, subject to a Consolidated List of Commitments specified in a settlement agreement supported by all parties to the proceeding. Included in this consolidated list is MEHC's and PacifiCorp's commitment regarding the filing of the enclosed Status Report. The commitments state:

49) Reporting on Status of Commitments:

By June 1, 2007 and each June 1 thereafter through June 1, 2011, PacifiCorp will file a report with the Commission regarding the implementation of the Commitments. The report will, at a minimum, provide a description of the performance of each of the commitments that have quantifiable results. If any of the commitments is not being met, relative to the specific terms of the commitment, the report shall provide proposed corrective measures and target dates for completion of such measures. PacifiCorp will make publicly available at the Commission non-confidential portions of the report.

U28) MEHC and PacifiCorp will supplement the report filed with the Commission, the Division and the Committee, pursuant to Commitment 49, by including information regarding the implementation of each of the Utah-Specific Commitments U 1 through U 27 and U 29 through U 46.

MEHC and PacifiCorp take the acquisition commitments very seriously. Fulfillment of the commitments in a thorough and timely manner is one of our highest priorities. The commitments are monitored for progress and compliance on a routine basis with status reporting provided to senior management.

You will note on the enclosed Status Report that the status of the commitments have been identified as "ongoing compliance" or "complete." Many of those commitments identified as "ongoing compliance" are of an on-going nature and do not have an expiration or completion date. For those commitments PacifiCorp has developed policies, procedures, or processes to ensure compliance as part of the Company's daily operations. Other commitments that are identified as "ongoing compliance" are project-related and the status will be reported as "complete" once the project has been completed. To date, 98 commitments across PacifiCorp's six-states have been completed. Of these 98 completed commitments, 21 are applicable to Utah and have been noted as "complete" on the Status Report. No commitments applicable to Utah were completed during this reporting period, April 1, 2008 to March 31, 2009.
