Re: *Informational Notice Regarding Norlight Inc.*

Dear Ms. Orchard:

Norlight, Inc. (“Norlight”), through its undersigned counsel and pursuant to the policies of the Utah Public Service Commission (“Commission”), hereby notifies the Commission of a transaction between the Norlight’s parent company, Q-Comm Corporation (“Q-Comm”), and Windstream Corporation (“Windstream”) pursuant to which Windstream will acquire, through an acquisition subsidiary formed for the purpose, the stock of Q-Comm and therefore indirect control of Norlight. Norlight is a competitive telecommunications service provider and provides resold interexchange telecommunications services in Utah pursuant to its registration filed with the Commission. For the Commission’s reference, charts illustrating the transaction and the pre- and post-transaction corporate ownership structure of Norlight are provided as Attachment A hereto.

This change in ultimate control of Norlight will not involve a transfer of its operating authority, assets or customers. Following the transaction, the existing customers of Norlight will remain customers of Norlight, and Norlight will continue to offer the same services, rates, terms and conditions pursuant to its existing authorizations. Accordingly, the transaction will be virtually transparent to Utah customers, who will continue to enjoy the same rates, terms and conditions of service as they do prior to closing.

Pre-Transaction Ownership of the Applicable Regulated Subsidiaries of Q-Comm and Windstream

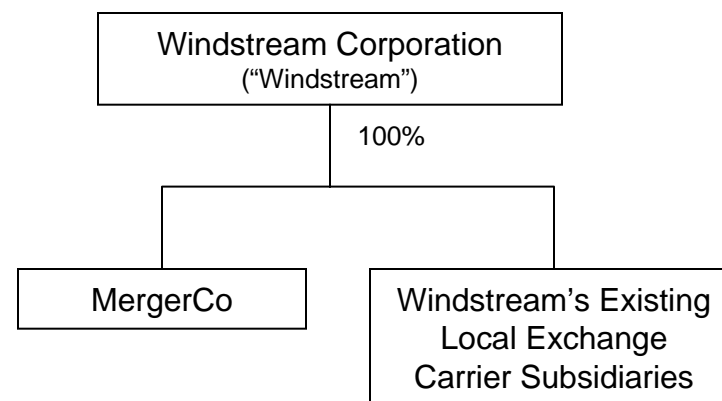
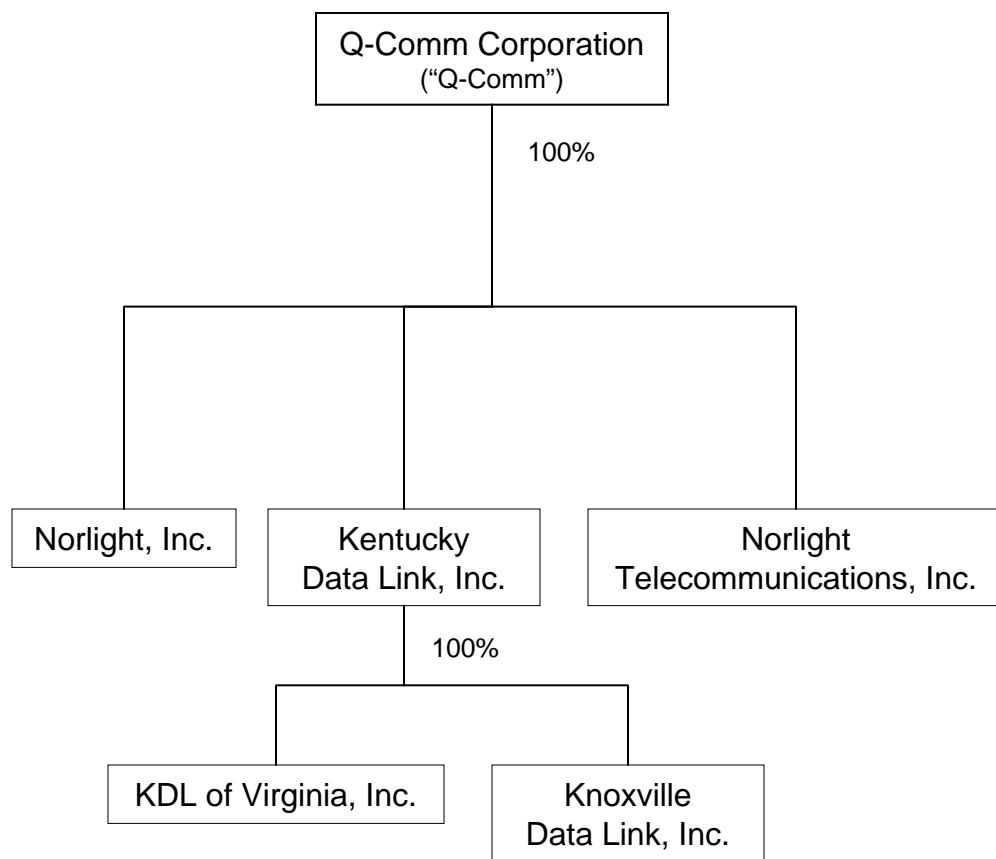
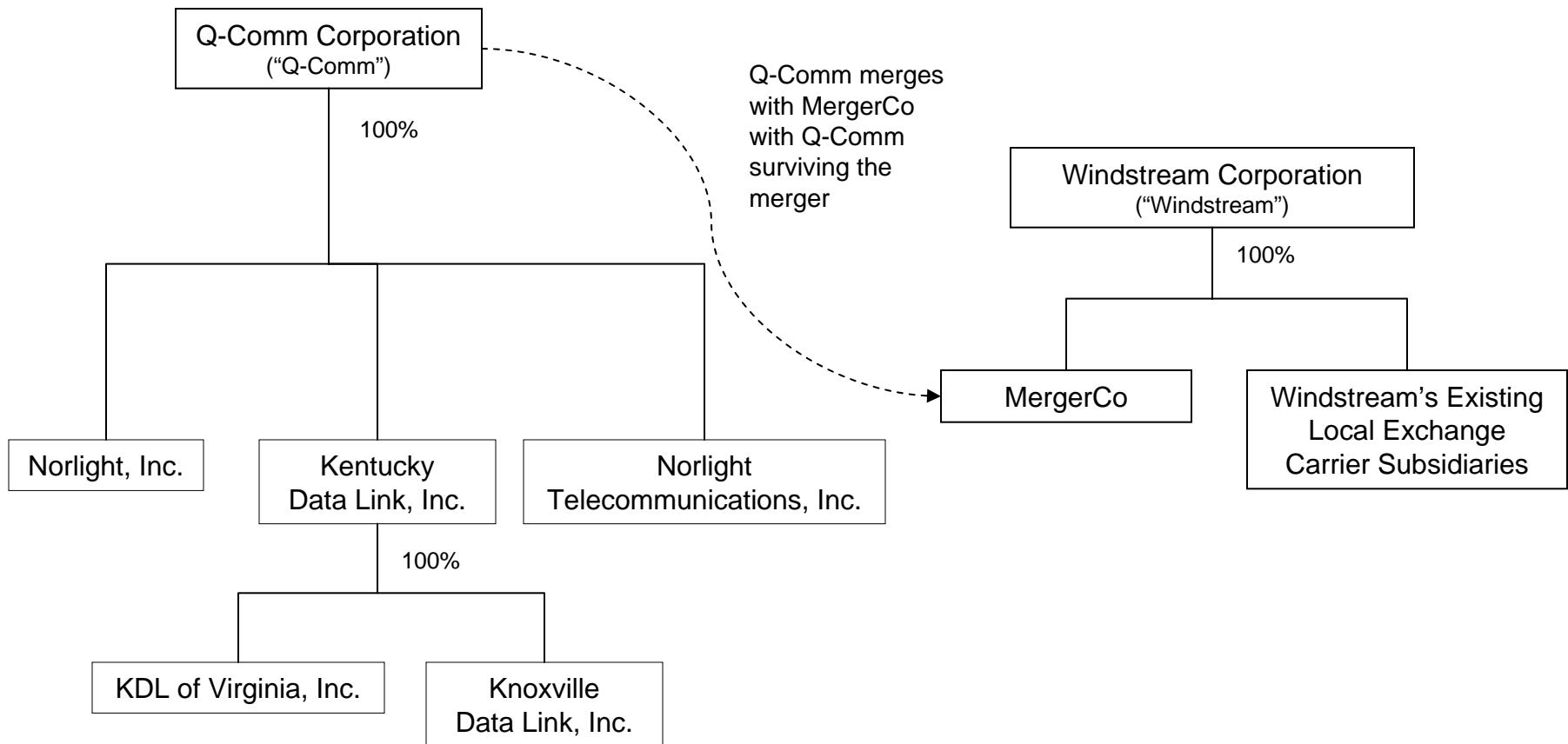


Illustration of Transaction
