The Universal Service Fund showed a balance of \$5,917,343 at the end of June, which was an increase of \$9,616 from the previous month. USF disbursements for the month totaled \$415,811. There were no Lifeline reimbursements during the month. Revenues for June totaled \$425,427. The fund balance has ranged between \$5.9 and \$7.6 million for the last 12 months.

During the month of June, the Speech/Hearing-Impaired Fund had expenditures of \$114,335. This total includes \$99,439 for professional and technical services, \$12,069 for operating supplies and maintenance, \$2,143 for travel reimbursement. The fund balance at the end of June was \$1,386,176. This fund balance has generally declined slightly each month since September 2006 when it was at a high of \$4.4 million. The high and low fund balances for the past 12 months were \$1.8 and \$1.4 million respectively. Expenditures from this fund are used primarily for the training and education of interpreters and to provide special telephone equipment for the hearing impaired.
