Section 63G-4-503 of the Utah Code Ann. provides that "[a]n agency may issue a declaratory order that would substantially prejudice the rights of a person who would be a necessary party, only if that person consents in writing to the determination of the matter by a declaratory proceeding." Utah Code Ann. § 63G-4-503(3)(b) (2008). By its petition for leave to intervene and appear specially, El Paso states it does not consent in writing to a determination of this matter by declaratory order. Additionally, El Paso asserts that it is not a "[p]ublic utility" under Utah law, see Utah Code Ann. § 54-2-1(16)(a) (2010), and therefore it is not subject to the Commission's jurisdiction. For these reasons, the Commission grants El Paso's request to appear specially herein.
