Citizens Telecommunications Company of Utah d/b/a Frontier Communications of Utah and Navajo Communications Company, Inc herein after referred to as "Frontier" hereby provides a copy of its Annual Lifeline Eligible Telecommunications Carrier Certification FCC Form 555 in compliance with 47 CFR 54.416 as adopted by the Federal Communication Commission (FCC) in its Lifeline Reform Order, FCC 12-11, released February 6, 2012.

Section 54.416(b) requires eligible telecommunication carriers (ETCs) to annually provide the results of their re-certification efforts performed pursuant to Section 54.410 (f) to the FCC and the Universal Service Administrative Company (USAC). ETCs are also required to provide the results of their re-certification efforts to state commissions and relevant tribal governments.

On January 31, 2014, Frontier filed a request for limited waiver with the FCC seeking a one week extension until February 7, 2014 to complete boxes J, K and L. and will supplement this filing with the updated information. Attached is a copy of the request for limited waiver filing.

FRONTIER COMMUNICATIONS CORPORATION REQUEST FOR LIMITED WAIVER

Frontier Communications Corporation ("Frontier") respectfully requests limited waiver of Section 54.416¹ of the Commission's rules pursuant to Section 1.3 of the Commission's rules.² Specifically, Frontier requests a one week waiver to complete FCC Form 555 Boxes J, K and L for its two study areas within the State of Utah: Navajo-UT-Frontier, SAC No. 504449, and Citizens-Frontier-UT, SAC No. 504429 ("Utah Study Areas").

The Commission requires in Section 54.416 an annual certification related to compliance with Lifeline policies and procedures, which is carried out through the filing of FCC Form 555, due January 31 annually. Good cause exists for limited waiver of this rule with respect to the Utah Study Areas for the January 31, 2014, filing. Frontier has completed its Form 555 submissions for 27 of its 28 states, which includes 89 of its 91 study areas excluding those in Utah, in time for filing on January 31, 2014. Unfortunately, an illness of the staff member dedicated to Lifeline at the Utah Public Service Commission ("PSC") has prevented Frontier

from obtaining the information necessary to complete boxes J, K and L on Form 555 for the Utah Study Areas.

Utah is a state that reviews Lifeline eligibility and thus Frontier cannot adequately provide the required information on subscribers' eligibility reviewed by the state without input from the Utah PSC. Frontier has completed all of the information within its possession and presumed box J to be the same as box A. Frontier expects to be able to supplement its response for the Utah Study Areas by February 7, 2014 (one week), during which time Frontier expects that the PSC staff member would either return to work or the PSC would be able to provide the requested information through an alternate source. In total, this represents less than 1,000 Lifeline subscribers, a small fraction of the nationwide total subscribership.

For the foregoing reasons Frontier respectfully requests the Commission to grant Frontier waiver to supplement its Utah Study Areas responses for boxes J, K and L by February 7, 2014.
