**SECTION 63.71 APPLICATION OF
NETWORK OPERATOR SERVICES, INC.**

Network Operator Services, Inc. (“Applicant”) seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. §214(a), and Section 63.71 of the Commission’s rules, 47 C.F.R. §63.71, to discontinue its provision of operator services nationwide. Notice of the proposed discontinuance is being filed simultaneously with the International Bureau pursuant to Section 63.19 of the Commission’s rules, 47 C.F.R. §63.19.

The Applicant provides the following information pursuant to Section 63.71 of the Commission’s Rules:

1. Name and Address of the Carrier: Network Operator Services, Inc. 119 W. Tyler Street, Suite 260, Longview, TX 75601.
2. Date of Planned Service Discontinuance: Applicant no longer has any customers and does not provide or offer any services. Applicant desires to formally relinquish its license.
3. Points of Geographic Areas of Service Affected: Applicant proposes to discontinue the affected services nationwide.

4. Description of Services Affected: Applicant formerly provided operator services nationwide, but has not had any customers since 2014.

5. Brief Description of the Dates and Method of Notice to All Affected Customers: Applicant no longer services any customers, and has not had any customers, in any state, since December 2014.

6. Whether the Carrier is Considered Dominant or Non-dominant with Respect to the Service to be Discontinued: Applicant is considered non-dominant with respect to the services to be discontinued.

7. Other information: In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the Special Assistant for Telecommunications to the Secretary of Defense, and to the Governors and Public Utility Commissions of Massachusetts, Nevada, New Mexico, New York, Rhode Island, Tennessee, Texas, Utah, Virginia, and West Virginia, where Applicant does not offer service, but is still in the process of withdrawing its state authorities.

Conclusion: The public convenience and necessity will not be adversely affected by the discontinuance of Applicant's operator services nationwide. There are no longer any customers to notify. Therefore, Applicant respectfully requests that the Commission approve this Section 63.71 application.
