The notification relayed the delay was associated with CenturyLink back office work activities that do not impact our customers' use of EASE. The notification included an updated Milestone Timeline (included below) to reflect the revised date of October 3, 2016 and stated that CenturyLink would also be updating the CenturyLink Access Service Ordering and Billing System Consolidation Plan to reflect the revised effective date.

The CenturyLink Access Service Ordering and Billing System Consolidation Plan Version 4 has been posted to the Access Systems Consolidation Project page at http://www.centurylink.com/wholesale/systems/ossconsolid_asr.html. The Consolidation Plan revisions are identified in the Document Modification Log and include changes to all references of the planned Release to Production date, changes to reflect ASOG 53 vs. ASOG 52, and additional information in regard to Load & Performance (L&P) Testing.

NOTE: Rather than sending multiple notifications for various functional areas to reflect the change in the Release to Production date, CenturyLink is conveying with this notification that all related functional and application changes that were to be effective on August 1, 2016 will now be effective with the revised Release to Production date of October 3, 2016.
