On June 22, 2017, Frontier Communications Corp. ("Frontier") filed its annual report and certifications, FCC Form 481, as required by Sections 54.313 and 54.422 of the Commission's rules. Line 2025 of the Form 481, however, does not offer any opportunity to provide revised data for previous year reports, and Frontier has minor revisions with respect to the Connect America Fund ("CAF") Phase I Round 2 incremental support locations it reported in its 2016 FCC Form 481. Attached, please find a list showing additional locations that Frontier had constructed in Years 1 or 2 of CAF Phase I Round 2¹ and another list showing locations Frontier believes no longer should have been included. As indicated on Line 2011 of Frontier's Form 481, Frontier has successfully deployed service to the required amount of locations to satisfy its CAF Phase I Round 2 obligations, and today's filing simply clarifies Frontier's final list of locations.
