**SECTION 63.71 APPLICATION**

Bright House Networks, LLC (“Bright House”)<sup>1</sup>, through its undersigned counsel and pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and Section 63.71 of the Commission’s rules, 47 C.F.R. § 63.71, hereby files this Application to discontinue offering certain interconnected VoIP services in Alabama, Colorado, Delaware, District of Columbia, Florida, Iowa, Minnesota, New Hampshire, South Dakota, Texas, Utah and Virginia (the “Service Areas”).

In support of its Application, Bright House submits the following information:

**Names and address of carrier:**

**Date of planned service discontinuance:**

Bright House intends to discontinue offering the services described in this Application on December 31, 2018, or as soon thereafter as federal approval may be obtained.

**Points of geographic areas of service affected:**

Bright House currently offers the services that are the subject of this Application in Alabama, Colorado, Delaware, District of Columbia, Florida, Iowa, Minnesota, New Hampshire, South Dakota, Texas, Utah and Virginia.

**Brief description of the type of service affected:**

Bright House intends to discontinue offering Hosted IP Voice service to new and existing customers. The Hosted IP Voice service is a hosted interconnected VoIP service provided to business customers. Business customers access the Hosted IP Voice service through several different service configurations, including T-1 or DS1 Internet transport, MPLS (multiprotocol label switching) transport, or workers' home Internet service (for work-at-home users). Bright House has a total of ten (10) customer accounts purchasing the service at twenty (20) service locations. Similar services are available in the Service Areas from other telecommunications carriers and interconnected VoIP providers.

**Brief description of the dates and methods of notice to all affected customers:**

Bright House mailed written notice to affected customers on October 1, 2018. A copy of the notice is attached at Exhibit "A" hereto.

**Non-dominance of the carrier with respect to the services to be discontinued:**

Bright House is non-dominant with respect to the services to be discontinued.

**Service:**

In accordance with Section 63.71 of the Commission's rules, Bright House has mailed copies of this Application to the Governor and to the state public service or utility commission in each of the states in the Service Area, as well as to the United States Secretary of Defense.

**Conclusion**

The public convenience and necessity will not be adversely affected by the discontinuance of the offering of these services because comparable services are available from other providers in the market. Bright House respectfully requests that the Commission approve the Section 63.71 Application of Bright House to discontinue offering Hosted IP Voice service, as described herein, in the Service Area.

As a result of standardizing our enterprise Voice Solutions portfolio we have decided that effective December 31, 2018, we will no longer provide or support certain Hosted Voice services that were previously delivered to your business by Bright House Networks, LLC and/or Telovations, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
