**RE:** Universal Service Funds Status Docket #18-999-09

Attached for your information is the latest status report on the Utah Universal Service Fund. All reported amounts are proprietary.

The Universal Service Fund showed a balance of \$8,042,704.45 at the end of November 2018, which is a net increase of \$141,414.01 from the previous month. High cost support disbursed to rural ILECs totaled \$893,620.93. Relay Utah disbursements for November were \$60,197.34. Contributions for November totaled \$1,095,232.28.

In November, 3 providers reported using revenue as a basis for remitting their USF contribution. Their contributions totaled \$22,082.88. The Division is continuing education efforts for providers that contribute under the old rules. 93 providers remitted USF based on connections. There were 3,010,835 connections reported for November. 1,235 connections were claimed as exempt by providers.
