PHMSA,

Dominion Energy Utah/Wyoming/Idaho, OPID: 12876, wishes to retract Incident Report Number 20180094- 31070 and supplemental Report Number 20180094- 31333 in response to NRC Report #1224724.

The Incident Report for the West Valley City, Utah fire on 9/15/2018 was submitted while waiting on final evidence reports that would conclusively prove the natural gas facilities involved were secondary ignition. At this time, Dominion Energy Utah (DEU) and Utah Office of Pipeline Safety find that the event does not meet any of the three guidance material conditions for secondary ignition as found in the General Instructions for the PHMSA Form 7100.1 and that the event was not a reportable incident under 191. DEU requests to retract the incident reports.
