Rocky Mountain Power Q2 2019 Hourly Qualifying Facility Purchases Report

Kennecott Smelter / Kennecott Refinery / Tesoro / US Magnesium

In its December 23, 2009 order in Docket No. 09-035-20 approving qualifying facility ("QF") sales from US Magnesium to Rocky Mountain Power ("RMP" or "Company"), and in subsequent approvals, the Public Service Commission of Utah ("UPSC") directed RMP to provide hourly power purchased under the power purchase agreement ("PPA") on a quarterly basis. In accordance with that order, RMP provides the hourly delivered energy from US Magnesium through Q1 2019 (January 1, 2019 through June 30, 2019). Similarly, the Company also provides hourly power purchased under the equivalent PPAs for Kennecott Smelter and Kennecott Refinery (Docket No. 08-035-83) and Tesoro (Docket No. 08-035-82).
