Broadview Networks, Inc., Business Telecom, LLC, CTC Communications Corp., DeltaCom, LLC, EarthLink Business, LLC, McLeodUSA Telecommunications Services, LLC, PAETEC Communications, LLC, Windstream Communications, LLC, and Windstream NuVox, LLC (collectively, the “WIN Regulated Subsidiaries”) hereby provides notice to the Public Service Commission of Utah that they and their parent entities, Windstream Holdings, Inc. and Windstream Services, LLC (collectively “Windstream”), filed a Petition under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York on February 25, 2019, in Case No. 19-22312. The filing of the Petition served to convert the legal status of Windstream to debtors-in-possession.<sup>1</sup> The bankruptcy filing did not result in any change to the current operations of Windstream, their address or the terms and conditions of their service.

This notice is being made as a courtesy and any required approval filings will be made subsequently. Windstream would like to emphasize that this filing will not interrupt any service operations, nor will it result in a change to the rates or terms of service provided to customers or offered to prospective customers. Windstream’s regulated entities in Utah intend to continue their existing operations without any change as a result of the filing of the Petition.


