**RE:** Universal Service Funds Status Docket #19-999-08

Attached for your information is the latest status report on the Utah Universal Service Fund. All reported amounts are proprietary.

The Universal Service Fund showed a balance of \$6,695,538.87 at the end of March 2019, which is a net decrease of \$369,004.34 from the previous month. High cost support disbursed to rural ILECs totaled \$1,584,263.08. Relay Utah disbursements for March were \$46,568.13. Lifeline disbursements for March totaled \$203,416.50. Contributions for March totaled \$1,465,243.37.

In March, no providers reported using revenue as a basis for remitting their USF contribution. 74 providers remitted USF based on connections. There were 4,109,606 connections subject to surcharge reported for March. 4,371 connections were claimed as exempt by providers.
