Attached for your information is the latest status report on the Utah Universal Service Fund. All reported amounts are proprietary.

The Universal Service Fund showed a balance of \$6,258,830.61 at the end of April 2019, which is a net decrease of \$436,708.26 from the previous month. High cost support disbursed to rural ILECs totaled \$1,584,263.08. Relay Utah disbursements for April were \$75,641.31. Contributions for April totaled \$1,224,807.49.

In April, two providers reported using revenue as a basis for remitting their USF contribution. 86 providers remitted USF based on connections. There were 3,382,663 connections subject to surcharge reported for April. 3,059 connections were claimed as exempt by providers.
