**RE:** Universal Service Funds Status Docket #19-999-08

Attached for your information is the latest status report on the Utah Universal Service Fund. All reported amounts are proprietary.

The Universal Service Fund showed a balance of \$6,947,480.29 at the end of October 2019, which is a net increase of \$174,016.72 from the previous month. High cost support disbursed to rural ILECs totaled \$1,584,263.08. Relay Utah disbursements for October were \$78,614.24. Utah Interactive transactions fees totaled \$9.00. Contributions for October totaled \$1,838,788.20.

In October, one provider reported using revenue as a basis for remitting their USF contribution. 87 providers remitted USF based on connections. Two providers used the incorrect surcharge to calculate their remittance. These companies have been notified of the error and asked to submit a correction. There were 3,105,978 connections subject to surcharge reported for October. Exempt connections claimed by providers totaled 5,282.
