Dear Mr. Widerburg:

Pursuant to Commitment U3(2), incorporated in the Public Service Commission of Utah's *Report and Order* approving the *Acquisition of PacifiCorp by MidAmerican Energy Holdings Company*¹, issued January 27, 2006, as amended March 14, 2006, and June 5, 2006, Rocky Mountain Power hereby provides notice of an affiliated interest transaction with the Coca-Cola Company, acting by and through Coca-Cola North America ("Coca-Cola") for the Coca-Cola Freestyle Equipment Agreement allowing PacifiCorp to lease and use four Coca-Cola Freestyle machines. A copy of the Coca-Cola Freestyle Equipment Agreement ("Agreement"), is included with this Notice as Attachment A.

PacifiCorp is a wholly-owned indirect subsidiary of Berkshire Hathaway Energy Company ("BHE"). BHE is a subsidiary of Berkshire Hathaway, Inc. Berkshire Hathaway, Inc. ownership share in Coca-Cola exceeds five percent. Therefore, Berkshire Hathaway, Inc.'s ownership interest in BHE and Coca-Cola creates an affiliated interest relationship between the Company and Coca-Cola in some Company jurisdictions.


PacifiCorp is installing the Coca-Cola Freestyle machines in its break rooms at Lloyd Center Tower in Portland, Oregon. The Coca-Cola Freestyle Agreement is a standard, arms-length agreement, and is at the current market rate.


