I hope this finds you doing well. Per DOT Part 195.505, this communication is to notify PHMSA that Kinder Morgan (OP ID 18092) has changed the span of control (SOC) for two tasks on the company's Hazardous Liquids covered task list. These changes are due to recent hazardous liquids subject matter expert reviews. SOC for tasks 104.15, General

Pipeline Repair – Stoppling, and 104.16, General Pipeline Repair – Hot Tap, will be changed from to 1:2 to 1:0. The effective date for this change is 6/14/2021.

This will affect all Hazardous Liquids pipelines operated by Kinder Morgan subject to the OQ program. These assets are present in all PHMSA regions and listed on page 6 of the attached copy of Kinder Morgan's OQ plan. Kinder Morgan's Hazardous Liquids Covered Task list (Appendix B) and Kinder Morgan's Liquid Terminals Covered Task list (Appendix J) are attached with changes indicated with yellow highlight.
