PROCEDURAL ORDER AND NOTICE OF TECHNICAL AND SCHEDULING CONFERENCE

By The Commission:

In response to All West Communications' (All West) Notice of Appearance of Counsel, Notice of Resumption of Proceeding, Petition for Scheduling Conference, and Supplement to Request for Agency Action filed on November 22, 2004, a scheduling conference was held before the Administrative Law Judge on December 6, 2004. Stephen F. Mecham appeared on behalf of All West Communications (All West). Gregory B. Monson appeared for Qwest Corporation (Qwest). Therefore, Qwest shall have until December 27, 2004, to file its Response to All West's Notice of November 22, 2004. In addition, PLEASE TAKE NOTICE that a Technical and Scheduling Conference will be held before the Administrative Law Judge on Friday, January 7, 2005, at 9:00 a.m. in Room 451 on the Fourth Floor of the Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah 84111. The purpose of the technical conference is to provide the parties an opportunity to discuss the issues brought before the Commission in this docket and to determine how best to proceed given the discovery and related matters that had been undertaken prior to this docket being placed on hold in 2002. The scheduling conference which follows will set a schedule for this docket based on the parties' discussions.
