Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Rule 746-100-7, Horizon Enterprises Inc. ("Horizon") respectfully petitions the Public Service Commission of Utah (the "Commission") for leave to intervene in the above-captioned proceeding concerning Qwest Corporation's Land Development Agreements tariff provisions in the state of Utah. In support of its petition, Horizon represents and states as follows:

1. Horizon is a business, for residential land development throughout the state of Utah, principally within the Cache Valley region.

2. As a residential land developer, within the telecommunications service area of Qwest Corporation, Horizon needs Qwest telephone networks to be developed in its projects here in Utah. The outcome of Qwest Corporation's LDA Tariff docket could result in significant added costs and construction delays to Horizon. Thus, the legal interests of Horizon could be directly affected by the outcome of this proceeding.

3. The interests of justice and the orderly and prompt conduct of this proceeding will not be impaired by allowing Horizon to intervene.

WHEREFORE, Horizon respectfully requests that the Commission enter an Order granting Horizon's Petition to Intervene as a party in this docket, allowing Horizon to participate to the full extent allowed by the rules of the Commission and by Utah law.
