Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Rule 746-100-7, Mainstreet Development, Inc. respectfully petitions the Public Service Commission of Utah (the "Commission") for leave to intervene in the above-captioned proceeding concerning Qwest Corporation's Land Development Agreements tariff provisions in the state of Utah. In support of its petition, Mainstreet Development, Inc. represents and states as follows:

1. Mainstreet Development, Inc. is a Land Developer formed to develop residential projects throughout the state of Utah.
2. As a developer, Mainstreet Development, Inc. is required to provide access to utility services in their projects. The outcome of Qwest Corporation's LDA Tariff docket could result in significant added construction time and costs to Mainstreet Development, Inc.. Thus, the legal interests of Mainstreet Development, Inc. could be directly affected by the outcome of this proceeding.

3. The interests of justice and the orderly and prompt conduct of this proceeding will not be impaired by allowing Mainstreet Development, Inc. to intervene.

WHEREFORE, Mainstreet Development, Inc. respectfully requests that the Commission enter an Order granting Mainstreet Development, Inc.'s Petition to Intervene as a party in this docket, allowing Mainstreet Development, Inc. to participate to the full extent allowed by the rules of the Commission and by Utah law.
