2. As a Developer/ Home Builder, Richmond American Homes is required by law to provide utilities, including telephone service, to the building lots we develop and /or the homes we build in Utah. The outcome of Qwest Corporation's LDA Tariff docket could result in significant added costs to consumers. This is due to increased development and home building time, caused by slow response time to project

timetables on the part of telephone and other utilities to Richmond American Homes. Thus, the legal interests of Richmond American Homes could be directly affected by the outcome of this proceeding.
