The outcome of Qwest Corporation's LDA Tariff docket could result in significant added costs to consumers. This is due to increased development and home building time, caused by slow response time to project timetables on the part of

telephone and other utilities to Elk Ridge Development. Thus, the legal interests of Elk Ridge Development could be directly affected by the outcome of this proceeding.
