Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Rule 746-100-7, Shron, Inc. respectfully petitions the Public Service Commission of Utah (the "Commission") for leave to intervene in the above-captioned proceeding concerning Qwest Corporation's Land Development Agreements tariff provisions in the state of Utah. In support of its petition, Shron, Inc. represents and states as follows:

1. Shron, Inc. is a Land Developer formed to develop residential projects throughout the state of Utah.
2. As a developer, Shron, Inc. is required to provide access to utility services in their projects. The outcome of Qwest Corporation's LDA Tariff docket could result in significant added construction time and costs to Shron, Inc.
