Qwest Corporation (“Qwest”), pursuant to Utah Code Ann. § 54-8B-2.1(3)(c), hereby gives notice of its intervention in the above-captioned matter. Qwest holds a certificate to provide public telecommunications service in the geographic area where Broadweave Networks of Utah, LLC (“Broadweave”) is seeking to provide telecommunications service, and thus qualifies for automatic status as an intervenor in this proceeding. *Id.*

Qwest takes no position at this time on whether Broadweave has “sufficient technical, financial, and managerial resources and abilities to provide the public telecommunications services applied for,” or whether “issuance of the certificate ... is in the public interest.” Utah Code Ann. § 54-8b-2.1(2). However, given an apparent direct or indirect relationship between Broadweave and the Traverse Mountain Master Planned Community (“Traverse Mountain”), where Broadweave intends to provide telecommunications services, Qwest’s intervention is intended to preserve its interest in appropriate competitive access to residential and business customers at Traverse Mountain.
