1. On page 1, the right hand caption should read as follows:

(This correction merely clarifies, in the caption, that it is a filing by SBS.)

2. In the “Conclusion” at pages 11 & 12 of the Reply Brief, one sentence was inadvertently deleted from the final draft. That sentence should read, “(3) that the Commission recognize the complete lack of legitimacy of Qwest’s *Option 2 Information Package* as fulfilling
