On November 23, 2004, Qwest Corporation (Qwest) and Union Cellular (Union) (collectively referred to hereinafter as the "Parties") submitted a Joint Motion to Vacate Procedural Schedule, Waive Statutory Deadline and Set Procedural Conference indicating that the Parties have begun negotiations over the terms and conditions for an interconnection agreement governing their relationship in Utah and therefore request a delay in these arbitration proceedings in order to continue those negotiations.
