modify the current schedule as follows:

On November 4, 2004, Uintah Basin Telecommunications Association, Inc. (UBTA), and UBET

Telecom, Inc. (UBET) jointly filed their response to the Committee's Motion. UBTA and UBET oppose the Motion generally on the grounds that the parties previously agreed to the current schedule and that any delay leading to failure
