42 RESPONSE TO LETTER FROM STANLEY K. STOLL 43 Paragraph 3: 44 UBTA-UBET does not have a true and correct viewpoint on how the UBET 45 customers in Uintah County really feel. There is a lot of mistrust and 46 resentment towards UBTA-UBET. This is the result of the billing errors on 47 the bills when they took over operations from QWest. The way UBTA-UBET 48 acted when it was seeking Extended Area Service (EAS) approval from the 49 Commission. 50 I have done two petitions in Uintah County. I can tell you that you do not 51 get as many signatures over such a short period of time as was done on the 52 EAS issue if people are happy. 53 UBTA-UBET presented a long list of endorsements of local government 54 bodies and community groups with its joint application for merger. I did not 55 attend any of the presentations done to get those approvals, but based on my 56 several years of attending meetings where such presentations are done; I 57 believe that most of these groups gave approval on the concept and not the 58 details since these presentations need to be of short duration and simple to

60 Most community groups try to present a positive attitude. They do not want 61 to be seen as opposing anything because it may affect their image. If the 62 groups had actually taken the time to fully study the issue, and if they were 63 willing to oppose something, then the approval list would most likely be much 64 shorter. 65 A petition opposing the merger was submitted at the hearing in Vernal, Utah on the 3rd of November, 2004, with more than sixty signatures. I found 66 67 this to be impressive since it was done over a very short period of time and it 68 was in complete opposition rather than just certain provisions of the merger. 69 The 17,000 subscribers do not have a true understanding of what 70 membership in the merged company means. It will take a few years, but the 71 UBET subscribers will come to dislike UBTA-UBET for giving them such a 72 raw deal. 73 UBTA-UBET's belief that I would spend all this time and money on a 74 viewpoint that is only held by me or a small minority is false. I have better 75 things to do than to fight against majority viewpoints. I live and work here, so 76 I choose my battles carefully so as to not create too many enemies.
