On October 15, 2004, Qwest Corporation (Qwest) filed its Motion to Compel Responses to Data Requests or, in the Alternative, Motion to Expand Data Requests, Motion to Vacate Procedural Schedule, Motion for Discovery Conference and Oral Argument, and Memorandum in Support of Motions. On October 21, 2004, due to the absence of the Administrative Law Judge, the Commission issued its Order granting Qwest's Motion to Vacate Procedural Schedule pending resolution of the discovery issues raised in Qwest's motions. On October 29, 2004, AT&T Corp. (AT&T) filed its Claimant's Opposition to Qwest's Motion to Compel in which AT&T continued to allege generally that several of Qwest's interrogatories are irrelevant, but withdrew its objection that Qwest had exceeded the maximum allowable number of interrogatories under Utah Rules of Civil Procedure Rule 33(a).

Because AT&T no longer objects to the number of interrogatories submitted by Qwest, Qwest's Motion to Expand Data Requests is moot. However, AT&T's continuing objection on the grounds of relevancy leaves unresolved Qwest's Motion to Compel and Motion for Discovery Conference and Oral Argument. Therefore, PLEASE TAKE NOTICE that Oral Argument on Qwest's Motion to Compel will be held before the Administrative Law Judge of the Public Service Commission of Utah on Wednesday, November 17, 2004, at 9:00 a.m. in the ALJ's hearing room, Room 451, Heber M. Wells Building, Salt Lake City, Utah. Immediately following Oral Argument and announcement of the Administrative Law Judge's decision on the Motion to Compel, a conference will be held to discuss continuing discovery issues and to establish a schedule for this docket going forward.
