Level 3 Communications, LLC (“Level 3”), by and through its undersigned counsel of record, hereby moves the Utah Public Service Commission (“Commission”) for an extension of time in which to file its Sur-Reply to Qwest Corporation’s (“Qwest”) Response to Level 3’s Reply Memorandum in Support of Motion for Entry of Order.

In accordance with the Commission’s grant of Qwest’s motion requesting leave to file a response to Level 3’s Reply Memorandum, Qwest filed its Response with the Commission on Friday, November 19, 2007. Pursuant to the Commission’s Order, Level 3 has ten days from November 19 in which to file its Sur-Reply, which would make the Sur-Reply due on Monday,

November 26, 2007. The timing of Qwest's Response in this particular matter would result in the ten-day response period including two weekends, one of which would be the long weekend of the Thanksgiving holiday period, which would leave Level 3 with only four business days in which to draft and file its Sur-Reply.
