Subject: Request for Information

Pursuant to statutory changes effective in May, 2005, the Utah Public Service Commission is authorized to provide funds to "an institution within the state system of higher education listed in Section 53B-1-1-102 for a program approved by the Board of Regents that trains persons to qualify as certified interpreters or the Division of Services for the Deaf and Hard of Hearing for a program that trains interpreters." Section 54-8b-10. The reference to certified interpreter means a person who is a certified interpreter under Title 53A, Chapter 26b, Interpreter Services for the Hearing Impaired Act. Section 54-8b-10. The Commission desires to implement the legislation in a manner that increases the number of certified interpreters in the State of Utah.

In order to assist the Commission in deciding how to use this new funding authorization, the Commission seeks additional information and comment on the current situation for certified interpreters in the State of Utah. This includes: what types of services are provided by certified interpreters, the supply and demand conditions for certified interpreter services throughout the State of Utah, the types of arrangements by which interpreter services are provided (e.g., personal employment, retainers, individual case service contracts, etc.); and difficulties in becoming a certified interpreter as well as difficulties in obtaining certified interpreter services thorough out the State of Utah. The Commission seeks to understand the current Utah circumstances regarding training for certified interpreters, the provision of certified interpreter services and what future goals or objectives can and should be pursued.

The Commission seeks information and comment on existing programs; their limitations, if any, in training persons to become certified interpreters; modifications which could be made to improve existing

programs' success in providing certified interpreters; and methods by which a given program's

effectiveness, improvement and success could be measured or evaluated. The Commission seeks similar

information and comment for any new programs which could be implemented to train persons to become

certified interpreters.
