On September 7, 2007, the Joint CLECs filed an Objection of Covad, Eschelon, Integra, McLeodUSA, and XO to Qwest Wire Center Designation, in which they object to Qwest's designation of its Orem central office as a Tier 2 wire center but do not object to designation of Qwest's Midvale office as a Tier 2 wire center. The Joint CLECs request the Commission schedule a procedural conference to establish a schedule for examining the data underlying Qwest's designation of the Orem central office as a Tier 2 wire center, including but not limited to establishing procedures to provide full review of the line count data Qwest uses to verify the data's accuracy.

Also on September 7, 2007, the Division of Public Utilities ("Division") filed a memorandum recommending approval of the Tier 2 designation for the Midvale wire center while agreeing with the Joint CLECs that further detailed investigation should be conducted regarding Qwest's Tier 2 designation for the Orem central office. The Division also recommends a procedural conference be scheduled to discuss a thorough review of the relevant data.
