	<b>UTAH OFFICE OF CONSUMER SERVICES' MOTION TO SHORTEN THE TIME TO RESPOND TO DATA REQUESTS</b>

The Utah Office of Consumer Services requests that the Commission shorten the “discovery turnaround” of 21 days to 10 days applied to discovery to all discovery filed after February 1, 2010, and to 3 days applied to discovery filed after February 26. This request is based upon the fact that allowing the greater period of 21 days under the circumstance where testimony is due February 12 and 26, effectively eliminates discovery pertaining to the testimony, particularly discovery pertaining to responsive testimony. In addition, the Commission’s customary practice is to shorten the time to respond to accommodate the parties’ needs as responsive and reply testimony is filed.
