Notice is hereby given that the Utah Rural Telecom Association, Petitioner, by and through counsel, petitions the Utah Supreme Court to review Respondent's Report and Order dated May 21, 2009 and Respondent's Order on Reconsideration, Review or Rehearing dated August 3, 2009 issued in Respondent's Docket No. 08-2476-02.

This petition seeks review of the following parts of the orders:

- 1.) Respondent's conclusion that there is substantial evidence that UBTA-UBET Communications, Inc. ("UBET") has essential facilities at Qwest's tandem switch in Provo;

- 2.) Respondent's decision that UBET must interconnect its facilities with Bresnan Broadband of Utah, Inc.'s ("Bresnan") facilities through indirect interconnection;
- 3.) Respondent's decision that UBET must interconnect its facilities with Bresnan's facilities outside UBET's service territory;
- 4.) Respondent's decision that UBET must terminate Bresnan's calls in the Extended Area Service areas without compensation; and,
- 5.) Any of Respondent's findings or conclusions incident to 1, 2, 3 or 4.

Petitioner requests the court to direct the Respondent to prepare and certify to the court its entire record, which shall include all of the proceedings and evidence taken in this matter.

Notice is hereby given that UBTA-UBET Communications, Inc. ("UBET"),
Petitioner, by and through its legal counsel, petitions the Utah Supreme Court to review
the Order of Respondent issued in this matter on May 21, 2009 and the Order on
Reconsideration, Review or Rehearing issued in this matter on August 3, 2009
(collectively the "Orders").

Pursuant to Title 63G, Chapter 4, Administrative Procedures Act, and Utah Code
Ann. § 78A-3-102(3)(e)(i), the Petitioner seeks review of the following portions of the
Orders:

1) Respondent's determination the State of Utah is not preempted by the Federal Telecommunications Act of 1996 in its regulation of IP enabled service; and its determination that UBET is obligated to interconnect to Bresnan Broadband of Utah, LLC ("Bresnan") under state law so that Bresnan can provide IP enabled service within UBET's local service territory;

2) Respondent's determination that UBET has essential facilities at Qwest's Provo Tandem;

3) Respondent's determination that UBET is required to indirectly interconnect with Bresnan outside UBET's service territory at the Qwest Provo Tandem;

4) Respondent's determination that UBET is not entitled to any additional extended area service ("EAS") compensation from Bresnan, on a flat fee or measured basis, to terminate calls outside of the Vernal exchange in UBET's EAS territory.

5) Any other of the Respondent's findings or conclusions ancillary to the issues set forth above.

Petitioner requests the Court to direct the Respondent to prepare and certify to the Court its entire record, which shall include all of the proceedings and evidence taken in this matter.
