**Re: CIMCO Communications, Inc. - Request to Cancel Interexchange
Registration**

Dear Filing Clerk:

CIMCO Communications, Inc. (now known as Cap Capital, Inc.) (the "Company"), by undersigned counsel, requests that the Commission cancel its interexchange registration effective March 16, 2010. The Company is authorized to provide resold interexchange services pursuant to its Initiation of Service Notification filed on July 25, 2008 (the "Registration").

On March 16, 2010, the Company completed a transaction with Comcast Phone, LLC whereby the Company transferred all of its assets and customers to Comcast Phone, LLC and certain of its affiliates.¹ As a result of the transaction, the Company no longer provides telecommunications services in Utah. The Company, therefore, no longer requires its Registration. Because the Company does not serve any customers or have any active telecommunications operations in Utah, the Company respectfully submits that the surrender of its Registration is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.


