Bresnan will provide the Commission with a copy of the fully executed Essential Facilities Agreement between the parties, as well as any other agreements reached regarding interconnection between Bresnan and UBET, through a Supplemental Status Report to be filed under separate cover in Docket No. 08-2478-02.

WHEREFORE, Petitioner BRESNAN BROADBAND OF UTAH, LLC respectfully requests that the Commission dismiss its Complaint against UBET, and grant the withdrawal of Bresnan's requests for relief sought in the Complaint with respect to any remedies beyond UBET's execution of the Essential Facilities Agreement approved and ordered in Docket No. 08-2476-02.
