Pursuant to the Commission’s Order on Reconsideration issued March 9, 2011, TracFone Wireless, Inc. (“TracFone”) files its Lifeline application form.

TracFone commenced providing Lifeline service in March 2011 in accordance with the Commission’s Amended Report and Order and Order on Limited Request for Reconsideration issued December 1, 2011. In the December 1, 2011 Order, the Commission granted TracFone’s petition for designation as an Eligible Telecommunications Carrier (“ETC”) and ordered that applicants for Lifeline service may receive service initially based on their own self-certification and that TracFone may use the Commission’s self-certification form or provide its own form that complies with R746-341-3.C. The Utah Rural Telecom Association and the Office of Consumer Service each requested the Commission to reconsider its December 1, 2011 Order. The Commission limited its reconsideration to the issue of TracFone’s obligation to pay into the

state Universal Service Fund. The Commission's Order Reconsideration issued March 9, 2011 requires TracFone to submit its Lifeline application form. A copy of the form is attached.
