11	MR. HUNTER: I am with Broadview Networks,
12	Inc.
13	JUDGE ARREDONDO: Thank you. Are you their
14	general counsel?
15	MR. HUNTER: Yes. One of my titles is
16	general counsel, yes.
17	JUDGE ARREDONDO: Okay. Thank you.
18	Anybody else on the phone with you?
19	MR. HUNTER: No. I'm here alone.
20	JUDGE ARREDONDO: Okay. And with the
21	Division?
22	MR. GINSBERG: Michael Ginsberg. And with
23	me is Ron Slusher, with the Division.
24	JUDGE ARREDONDO: Okay. Thank you.

And with that, let's go ahead and begin.

- 1 The Commission does have the recommendation of the
- 2 Division, filed October 29th, 2009, recommending
- 3 approval of the certificate. And is Mr. Slusher
- 4 going to testify?
- 5 MR. GINSBERG: Yes. We could put on some
- 6 brief testimony.
- 7 JUDGE ARREDONDO: Mr. Slusher, if you could
- 8 raise your right hand for me.
- 9 RON SLUSHER
- 10 called as a witness and sworn, was examined and
- 11 testified as follows:
- 12 JUDGE ARREDONDO: Thank you. Go ahead.
- 13 DIRECT EXAMINATION
- 14 BY MR. GINSBERG:
- 15 Q Can you state your name for the record and
- 16 what your position is?
- 17 A My name is Ron Slusher, S-L-U-S-H-E-R, and
- 18 I'm a tech consultant for the Division of Public
- 19 Utilities.
- 20 Q And what was your role with respect to this
- 21 application for certificate by this company?
- 22 A I reviewed the customer's application and
- 23 submitted the recommendation to the Commission.
- 24 Q So you prepared the October 29th memorandum
- 25 that was referred to?

- 1 A I did.
- 2 Q Can you provide a brief summary of your
- 3 recommendations?
- 4 A Sure. On October 15th, Broadview Networks
- 5 submitted an application to the Division for a
- 6 certificate of public convenience and necessity. The
- 7 Division reviewed their technical, managerial, and
- 8 financial abilities and found that they fulfilled the
- 9 requirements in the existing Commission rules.
- They requested that the hundred thousand
- dollar bond be waived, and we would agree with that,
- 12 and they also plan to operate as a provider of resold
- and facility-based interexchange and nonswitched
- 14 local exchange telecommunications services throughout
- the state of Utah, excluding the areas of 5,000
- access lines and carriers with fewer than 30,000
- 17 access lines.
- 18 Q Do you have any other additional comments?
- 19 A I do not.
- MR. GINSBERG: That's all we have.
- JUDGE ARREDONDO: Okay. Thank you,
- 22 Mr. Slusher.
- 23 Mr. Hunter, anything you'd like to add?
- MR. HUNTER: No. I think that covered it
- 25 rather well.

1	JUDGE ARREDONDO: All right. Thank you.
2	Then with that, the Commission will note the
3	recommendation of the Division and the testimony
4	today. We're recommending approval. I'll make a
5	recommendation to the Commission that we issue the
6	certificate. And that's the end of our hearing.
