QWEST'S AND CENTURYLINK'S SUBMISSION OF ERRATA HIGHLY-CONFIDENTIAL PROTECTIVE ORDER IN COMPLIANCE WITH OCTOBER 6, 2010 REPORT AND ORDER

Pursuant to the Commission's October 6, 2010 Report and Order in this proceeding, Qwest Communications International, Inc. and CenturyLink, Inc. (hereafter "Joint Applicants") hereby submit an errata protective order for "highly-confidential" information that complies with the Commission's Report and Order. As the Commission required, the errata protective order, attached as Attachment 1, is the same as the one that was attached as Attachment A to the Joint Applicants' July 22, 2010 motion for a protective order, but with all "Staff's Eyes Only" ("SEO") provisions deleted. The Joint Applicants have shared a red-lined version with the Joint CLECs' attorney so that he can see that all references to "Staff's Eyes Only" or "SEO" have been deleted.

Finally, it is the Joint Applicants' view that the issuance of the new protective order will make Integra's recent motion to compel *moot*. That is, in light of the protections in the new protective order that the Commission's Report and Order has adopted, the Joint Applicants will voluntarily produce, under the "Highly-Confidential" portion of that new protective order (Exhibit C), all remaining Hart-Scott-Rodino ("HSR") documents that are at issue in Integra's

motion to compel. Thus, there is no need for the Commission to rule on Integra's motion to compel, as the Joint Applicants will promptly produce all remaining disputed HSR documents upon counsel's signing of Exhibit C of the errata protective order. Counsel for Qwest has discussed this issue with Integra's counsel, and Integra concurs that the production of all HSR documents will make the motion to compel to be moot.
