Pursuant to Utah Administrative Code R746-100-3(1) the Division of Public Utilities (Division) has indicated it intends to file comments regarding South Central Utah Telephone Association's (SCUTA) request for interim USF no later than February 22, 2011. SCUTA has requested an extension of time until February 22, 2011 to respond to a Division's 4<sup>th</sup> set of data requests. The Division feels such an extension is appropriate and needs the response to the data request to adequately advise the Commission regarding SCUTA's request for interim USF. In the interim, the Division is concerned that the Commission might proceed on the SCUTA's request for interim relief. The Division believes, and understands SCUTA to agree, that waiting to proceed until the Division has had an opportunity to review the response to the data request and act thereon is appropriate.
