This bond is intended to provide security for customer deposits or other liabilities to telecommunications customers of the Applicant. InTTec does not plan to collect customer deposits or offer any prepaid services in Utah. InTTec hereby requests a waiver of this bond requirement.

InTTec will offer service through interconnection and commercial agreements utilizing the facilities of Qwest Corporation ("Qwest"), the incumbent local exchange company. InTTec will rely on its facilities-based underlying carrier for the operation and maintenance of the local exchange network.

4. R746-349-3(A)(4) Services to be offered

The Applicant's initial service offerings will include standalone Digital Subscriber Line on a resold basis.

InTTec initially proposes to offer basic local exchange services targeted at business and customers throughout the state leveraging associations with these customers in other certificated states.

InTTec's initial focus will be in the service territory of Qwest Corporation, in those locations where DSL is offered.

InTTec has no timetable established for the commencement of local services, whether resold or facilities-based. The company has a very limited market segment it will offer services to, as was mentioned in Section 4(a), therefore no concrete timetable has been established.
