Judge Arredondo,

The January 26, 2011 scheduling order in the i-wireless ETC docket requires that the Office notify the Commission whether the Solix contract dispute has been resolved. As you are aware, the Office sought the

Solix contract in the Virgin Mobile docket, 10-2521-01, a matter before Judge Clark, as well as in this docket. In the last few days Virgin Mobile has agreed to supplement its testimony on the issues of concern. Parties to the Virgin Mobile docket may file responsive testimony. The Office's discussion with Solix is applicable to i-wireless. Mr. Steinhart, i wireless' counsel, informed me that i-wireless will also supplement its testimony within the next week. Office and other's responsive testimony is due March 3. We may ask for additional time to respond but do not believe that the balance of the schedule need be changed. The Office has asked that no action be taken on its motions in Virgin Mobile's case and anticipates that they will be moot. With i wireless' supplemental testimony and an opportunity to respond, the Office considers the dispute over the Solix contract to be resolved. Thank you.
