Over the past year and a half, the Utah Public Service Commission

("Commission"), the Division of Public Utilities ("Division"), the Office of Consumer Services, and many other interested parties have worked to develop a Lifeline certification and annual verification process in response to direction from the Federal Communications Commission ("FCC"). The Department of Workforce Services ("DWS") administers a variety of the public assistance programs, participation in which qualifies the participant for Lifeline. Consequently, efforts have been ongoing to utilize DWS expertise and databases in the certification and annual verification process. In the past, the Commission has contracted with DWS to operate the Lifeline program. The Division has been involved in monitoring DWS' performance under this contract.

On May 10, 2013, the Division filed a memo ("Division's proposal") regarding "Federal Lifeline Compliance" in the above-referenced docket. The Division's memo recommends changes to Commission rules governing the certification and annual verification process. Among other things, these changes would establish a process by which both wireless and wireline carriers would eventually perform the annual verifications. The verification process could include querying DWS databases to verify participation in a qualifying public assistance program.
