## WRITTEN CLAIM OF BUSINESS CONFIDENTIALITY FOR FINANCIAL DOCUMENTS OF MOBILITIE, LLC

Mobilitie, LLC ("Mobilitie"), by its attorneys, hereby submits its written claim of business confidentiality and financial documents pursuant to the Utah Government Records Access and Management Act, Utah Code Ann. § 63-2-301 et seq. Mobilitie is filing these documents simultaneously with its Application for a Certificate to Provide Public Telecommunications Service, submitted under separate cover.

Mobilitie requests that these documents be considered confidential, protected documents under Utah Code Ann. § 63-2-304(2), which requires that the following be classified as "protected" documents:

- (2) commercial information or nonindividual financial information obtained from a person if:
  - (a) disclosure of the information could reasonably be expected to result in unfair competitive injury to the person submitting the information or would impair the ability of the governmental entity to obtain necessary information in the future;
  - (b) the person submitting the information has a greater interest in prohibiting access than the public in obtaining access; and
  - (c) the person submitting the information has provided the governmental entity with the information specified in Section 63-2-308.

Mobilitie is submitting its financial documents in conjunction with its application to demonstrate its financial ability to provide service. These documents meet the three foregoing characteristics required to classify them as protected documents. First, the documents contain

critical, commercially sensitive and competitively significant data regarding the number of Mobilitie's customers, its revenues per customer, and its marketing plans.

Second, Mobilitie has a greater interest in prohibiting access to these financial documents than the public does in obtaining access to such documents. This information could potentially be used by competitors and prospective competitors to gain an advantage over Mobilitie in the marketplace. In addition, the information requested is valuable and is used by Mobilitie for internal planning and business purposes.

Third, Mobilitie is submitting this "written claim of business confidentiality" required by Utah Code Ann. § 63-2-308 for any items that an applicant believes should be protected under Subsection 63-2-304(1) or (2).

Accordingly, Mobilitie respectfully requests that its financial documents be classified as "protected" pursuant to Utah Code Ann. § 63-2-301 et seq.



#### BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Mobilitie, LLC (Mobilitie) has applied for a certificate to provide Alternative Access Vendor (AAV) services pursuant to Section 364.337, Florida Statutes. Upon review of its application, it appears that Mobilitie has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant Certificate No. TA079 to Mobilitie.

If this Order becomes final and effective, it shall serve as Mobilitie's certificate. Mobilitie should, therefore, retain this Order as proof of certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.337, Florida Statutes.

AAV providers are subject to Chapter 25-24, Florida Administrative Code, Part XIV, Rules Governing Alternative Access Vendor services. AAV providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to Mobilitie for payment by January 30th. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve Mobilitie from its obligation to pay RAFs.

Based on the foregoing, it

ORDERED by the Florida Public Service Commission that we hereby grant Certificate No. TA079 to Mobilitie, LLC, which shall authorize it to provide Alternative Access Vendor services, subject to the terms and conditions specified in the body of this Order. It is further
