By The Commission:

This matter is before the Commission on the Notification Regarding the Indirect

Transfer of Control of CTC Communications Corp. to EarthLink, Inc. Pursuant to Utah Code Ann.

§ 54-3-28, 54-4-29, and 54-4-30, public utilities must obtain commission approval where merger,

consolidation or combination is proposed, or where a public utility is acquiring the voting stock or

securities of another public utility, or where a public utility is acquiring the properties of another.

See also Utah Admin. Code R746-349-7.

In the January 2010 Notification, EarthLink, Inc. (EarthLink), One

Communications Corp. (ONE), and CTC Communications Corp. (CTC) notified the

Commission of the indirect transfer of control of CTC to EarthLink. The parties further

represented:

Although EarthLink's acquisition of ONE will result in a change in the ultimate ownership and control of CTC, *no transfer of authorization, assets, or customers will occur as a result of the transfer of control.* Immediately following consummation of the merger, CTC will continue to provide service to its customers pursuant to its existing authorizations, with no change in the rates or terms and conditions of service as currently provided. The transfer of control will be transparent to customers of CTC in terms of the services they currently receive, and any changes that may occur in the future as to CTC's name or services will be made in accordance with the Commission's rules and procedures.

*Notification*, p.4 (emphasis added). As no "transfer of authorization, assets, or customers will occur as a result of the transfer of control", the Commission finds the transaction does not require Commission approval. The transaction was slated to occur as of December 20, 2010.

The Division submitted its recommendation on January 18, 2011 finding the transaction was in the public interest.

## ORDER

The parties shall notify the Commission of the consummation of the merger resulting in the indirect transfer of control of CTC to EarthLink.
